## Increase in Standard Cover for Locks & Keys

<p>If the keys, lock transmitter or entry card for a keyless entry system of <b>the car</b> are lost or stolen, <b>we</b> will pay up to £500 towards the cost of replacing:</p> <ul style="list-style-type: none"><li>• all entry locks that can be opened by the missing item; and</li><li>• the lock transmitter, entry card and central locking system; and</li><li>• the ignition and steering lock.</li></ul> <p><b>We</b> will also pay the cost of protecting <b>the car</b>, transporting it to the nearest repairers when necessary and delivering it to <b>your</b> address after repair.</p> <p>A claim under this section only will not affect <b>your</b> No Claim Discount.</p>	<p>If the keys, lock transmitter or entry card for a keyless entry system of <b>the car</b> are lost or stolen, <b>we</b> will pay up to £750 towards the cost of replacing:</p> <ul style="list-style-type: none"><li>• all entry locks that can be opened by the missing item; and</li><li>• the lock transmitter, entry card and central locking system; and</li><li>• the ignition and steering lock.</li></ul> <p><b>We</b> will also pay the cost of protecting <b>the car</b>, transporting it to the nearest repairers when necessary and delivering it to <b>your</b> address after repair.</p> <p>A claim under this section only will not affect <b>your</b> No Claim Discount.</p>	<p>This means the limit that we will pay up to for claims involving your keys, lock transmitter or entry card for a keyless entry system has been <b>increased from £500 to £750</b>.</p>
